IN RE: COURT OPERATIONS UNDER THE EXIGENT CIRCUMSTANCES CREATED BY THE OUTBREAK OF CORONAVIRUS DISEASE 2019 (COVID-19): CERTIFICATION OF VACCINATION STATUS

ADMINISTRATIVE ORDER

The United States Bankruptcy Court for the Eastern and Western Districts of Arkansas has continued to closely monitor the outbreak of Coronavirus Disease 2019 (COVID-19), as well as the developing guidance from the Centers for Disease Control and Prevention (CDC) and state and local health authorities. Notwithstanding a well-established COVID-19 vaccination effort, many adult Americans eligible for vaccination remain unvaccinated, and the COVID-19 Delta variant has caused a dramatic spike in COVID-19 cases across the United States and Arkansas. The risk posed by the spread of the Delta variant supports the review of our current safety protocols.

On July 29, 2021, President Biden announced that all qualifying federal employees, as well as federal contractors, are required to be vaccinated against COVID-19 or be subject to certain health and safety requirements. On September 9, 2021, President Biden issued executive orders regarding vaccination requirements for all qualifying federal employees and federal contractors. This Court is reviewing the President's policy and anticipates receiving further guidance. The safety of Court employees, judges, contractors, litigants, counsel, and members of the public that enter the courthouse is a critical priority. As part of the review process, the court is examining the need for additional safety protocols.

In order to complete the review and address any additional safety protocols, all Court employees, including all chambers staff, are expected to complete a vaccination certification form. In addition, all on-site federal contractors entering the U.S. Bankruptcy Court, 300 W. 2nd Street,

Little Rock, Arkansas are required to complete a vaccination certification form. The form is attached to this order and should be completed no later than Monday, October 4, 2021. Chambers staff should return their certification form directly to their appointing Judge. The court is inquiring about vaccination status for purposes of COVID-19 planning and implementing additional safety protocols. Vaccination certification forms will be protected and maintained in a way that ensures they remain confidential.

During the review period, the Administrative Order requiring the use of masks or face coverings dated May 21, 2021 remains in effect.
